WHO WE ARE AND WHAT THIS AGREEMENT DOES

We Alef Education Consultancy LLC (**Alef Education**) a company registered in Abu Dhabi with commercial license CN-2209313 license you to access and use:

- the nursing program you connect to via the Alef Platform and the content we provide to you through it (**Service**),

as permitted in these terms.

PRIVACY

By using the Alef Platform and the Service, you will be provided restricted access to your child or dependent's data relating to their use of the Alef Platform. You warrant that you are parent, guardian or custodian of the child or dependent and entitled to access that data under the law.

YOU MUST BE 21 TO ACCEPT THESE TERMS

You must be of the age of 21 or over to accept these Terms. If you are under the age of 21, your parent or guardian must assent to these terms on your behalf and takes full responsibility for your compliance with them.

YOU MAY NOT TRANSFER THE ALEF PLATFORM TO SOMEONE ELSE

We are giving you personally the right to use the Alef Platform and the Service as set out in these Terms. You may not otherwise transfer the Alef Platform or the Service to someone else, whether for money, for anything else or for free. If you sell any device on which the Alef Platform is installed, you must remove the Alef Platform from it.

CHANGES TO THESE TERMS

LICENCE RESTRICTIONS

You agree that you will:

EVEN IF WE DELAY IN ENFORCING THESE TERMS, WE CAN STILL ENFORCE THEM LATER

Even if we delay in enforcing these Terms, we can still enforce it later. If we do not insist immediately that you do anything you are required to do under these terms, or if we delay in taking steps against you in respect of your breaching these Terms, that will not mean that you do not have to do those things and it will not prevent us taking steps against you at a later date.

WHICH LAWS APPLY TO THIS CONTRACT AND WHERE YOU MAY BRING LEGAL PROCEEDINGS

These Terms shall be governed by and interpreted in accordance with the laws of England and Wales. You hereby irrevocably submit to the exclusive jurisdiction of the courts of Abu Dhabi Global Market to settle any dispute or claim you may bring arising out of or connection with these terms (including any non-contractual disputes or claims).
